### Queensland Rail's 2020–21 capital expenditure claim

Queensland Rail's 2020 access undertaking (AU2) provides for the QCA to assess the prudence of capital expenditure in Queensland Rail's West Moreton Network, after the expenditure has taken place, to determine whether it should be included in the regulatory asset base (RAB).

In assessing the prudence of capital expenditure, we focus on the **scope, standard of works and cost**.

Schedule E of AU2 outlines processes and criteria for our assessment.

In accordance with schedule E of AU2, we are now seeking submissions from stakeholders on Queensland Rail's 2020–21 capital expenditure claim.

At this time, we consider it may not be necessary for us to seek further engineering advice on the scope, standard and costs of projects included in the 2020-21 claim given the nature of the projects particularly when the costs of this advice are ultimately borne by customers. However, if stakeholders consider there are aspects of the claim which would benefit from seeking additional independent advice, please include these views in your submission.

#### Queensland Rail's claim

Queensland Rail submitted its 2020–21 capital expenditure claim on 30 December 2021. The claim encompasses eight projects plus ballast undercutting totalling \$37.5 million (excluding interest during construction), as outlined in Table 1. Queensland Rail provided detail for each project in its submission.

## Confidentiality

In the interests of transparency and to promote informed discussion and consultation, the QCA intends to make all submissions publicly available. However, if a person making a submission believes that information in the submission is confidential, that person should claim confidentiality in respect of the document (or the relevant part of the document) at the time the submission is given to the QCA and state the basis for the confidentiality claim.

The assessment of confidentiality claims will be made by the QCA in accordance with the *Queensland Competition Authority Act 1997*, including an assessment of whether disclosure of the information would damage the person's commercial activities and considerations of the public interest.

Claims for confidentiality should be clearly noted on the front page of the submission. The relevant sections of the submission should also be marked as confidential, so that the remainder of the document can be made publicly available. It would also be appreciated if two versions of the submission (i.e. a complete version and another excising confidential information) could be provided.

A confidentiality claim template is available on request. We encourage stakeholders to use this template when making confidentiality claims. The confidentiality claim template provides guidance on the type of information that would assist our assessment of claims for confidentiality.
